STATUS OF OUR NATIONAL REGISTER APPLICATION

On February 9, 2007, our Historical Society submitted to the Ohio State Preservation Office a full application to place the Ealy House on the National Register of Historic Places. In June an Ohio State Commission will approve or disapprove of the Ealy House's inclusion. If approved, the application then will be forwarded for a final decision to a Commission acting on behalf of the Park Service in the Department of the Interior. BOARD MEETING HIGHLIGHTS

JAN. 25 -- Dryer House roof and easements were discussed. Plans were made for packing up more stuff at the Museum and moving as much as feasible to the Dryer House on upcoming Saturdays.

FEB. 22 — The high gas bill at the K-H House was explained by the Treasurer. Founders Day plans were presented. The Founders Day Commission will finally get their own tax I.D. number. They have decided to choose the grand marshal themselves, and any nominations must be received by the 19th. They will sponsor the parade. Our Society will again sponsor the Ethel Schleppi Art Show and hold a bake sale. We will have four tables with the canopy. Liz Feichter suggested we display one or more scrap books owned by the Society; Kim Cathell suggested we display our collection of Indian projectile points, and other suggestions included quilts and blacksmith tools.

We need interior decoration plans for the Ealy House & landscape plans. We discussed the possibility of a corporate partner. Nancy Ferguson offered to check out Sandy Heffner, who is an interior designer.

The subject of fund raisers came up, and some of the suggestions were postcards of local scenes, greeting cards, a car show, and working with "Super Suppers." We will try to make a display of the Ealy House for Founders Day to cultivate interest in helping us decorate and furnish the museum. We will continue Market Days in the summer and have a garage sale in the fall. (There will not be a golf outing this year.) A volunteer will check on Craig's List. More possibilities: a boutique at the Ealy House, and a tea or series of teas when the house opens. More ideas: get sponsors for rooms in the Ealy House, and for landscaping; make notecards from sketches and paintings of local scenes.

MINUTES OF THE SOCIETY MEETING OF MARCH 1
