This year's Founders Day will take place on Saturday, May 18th, and it promises to be even bigger and better than ever. For example, in the Elementary School Gym there will be a display from Roscoe Village, with a canal boat replica, and weavers working at a loom. The Harlem Township Historical Society will be present with displays of antique implements. Jean Champoux will be there with her collection of chatelaines (remember her program at our August meeting?) and Marilyn Regrut with a button display. Dennis Keesee will also be there with a Civil War exhibit. Our own Society booth will feature the Heritage Quilt and various old maps and photographs. # THE ROCKY FORK METRO PARK & THE NAPTH SOCIETY

#### MARJORIE PESTEL (1926-2013)

The daughter of Clarence and Thirza Piper, Marjorie Ellen Piper was born on February 15, 1926, in Harlem Township, Delaware County, near Center Village, where she was raised along with two sisters and five brothers. She married Rollie Pestel on June 29, 1947. They moved to Plain Township at that time and resided at both of the Pestel farms until 1984, when they moved to a house a couple of houses north of the New Albany Schools on State Route 605. Margie was widowed on November 17, 2007.

Margie was active in farm organizations, the New Albany United Methodist Church, and the New Albany Lions Ladies Auxiliary, in addition to the New Albany-Plain Township Historical Society. She was best known in our Society for volunteering at the Tuesday morning work days at the Kern-Harrington House, stirring apple butter at the Harvest of the Arts Festival, and as a call committee member. We all appreciated her kind spirit and good nature. She enjoyed traveling with the Still Going Strong seniors group from Westerville and with World-wide Country Tours. She died this past January 31, survived by two daughters, Wilma and Diana, their spouses, two grandchildren and their spouses, four great-grandchildren, and three brothers.

At the request of Bill Buescher, landscape architect for the Franklin County Metro Parks, John Saveson and Dennis Keesee met with him to provide historical information about the Plain Township land which is destined to be included in the Rocky Fork Metro Park. Of particular interest to Mr. Buescher is the parcel acquired a few years ago in the vicinity of the Walnut-Harlem intersection, where Rocky Fork Creek crosses Walnut Street. This parcel originally included a very old house built by the Cashner family. In recent times known as the Garrett home, it was torn down a few years ago. A Cashner saw mill is shown at the same location on the 1872 Plain Township map. Mr. Buescher has the idea of making a small park area on that property, perhaps with a picnic area.

In preparation for the meeting (which took place on March 5 at the Ealy House), John Saveson wrote a 2-page summary of the historic features of the future Metro Park area. He indicated the locations of the 2 one-room schools, the old houses (some of which are still standing), the sites where Indian artifacts have been found, even the location of a former church. On the 1856 map, this building is called the Temperance Church; on the 1872 map it is called the Albright Church -- some interesting history right there. Some of the old family names in the future park area are Alspach, Bevelhymer, Brooks, Butsko, Miller, Cubbage Needles, Pestel, Schleppi, and Tippett. For anyone interested in reading John's whole report, it is accessible on our Society web site.

## NEW ALBANY-PLAIN TOWNSHIP HISTORICAL SOCIETY GENERAL MEETING FEBRUARY 7, 2013 PLAIN TOWNSHIP FIRE STATION

The meeting was called to order by President, Marilyn Regrut. She introduced special guest John O'Connor. Other guests attending were Linda and Michael Myhal and Louis Schultz.

The minutes of the November meeting were read by Secretary, Liz Feichter. There were no corrections and David Cline made a motion to accept. Helen Pestel seconded the motion and they were approved.

The Treasurer's report was read by Helen Pestel. Betty Maynard made a motion to accept the report, Liz Feichter seconded and it was approved.

The 2013 budget was read and approved. Liz Feichter made a motion to accept the budget and David Cline seconded. A copy is attached to the minutes.

Thanks to David Cline and Nancy Ferguson for the days spent with the electricians. We have lighting in the attic which displays the names on the walls, now easy to read. We have lights on the stairs to the basement.

We still need estimates for the repair of the pantry.

The New Albany Chamber of Commerce is sponsoring a Spring Fling Business and Community Expo on March 21<sup>st</sup>. The Historical Society has been asked to participate with one table. The hours are 4 to 6 PM and set up at 3PM. We can display anything. The Ealy House will be open from 3PM to 5PM.

Because our reconstruction jobs are relatively small, it has been difficult to obtain three bids. Marilyn suggested we have a committee to review the Constitution and By-laws and make suggestions to the Board for revisions and approval by the Society. Liz Feichter, Marty Saveson, David Cline and Monica Morgan will serve on the committee.

David Cline made a motion to purchase a telephone-answering machine. It was decided the phone should be cordless and the answering machine to have remote access. The Society has received notice from the New Albany Arts Council that Harvest of the Arts will be discontinued. It was becoming difficult for our small organizations to follow all of the food handling guidelines and attendance has been down. There has been some difficulty in getting workers and we have had considerable competition from other venues.

Catherine Saveson announced she had made some changes to the web site.

Marty Saveson announced a progam at Otterbein on history of the Underground and an open house at Hanby House following the program.

Dennis Keesee presented our program on a diary he purchased off E-Bay written by a Plain Township resident during the Civil War. Dennis always has an interesting program and I regret we were unable to tape this.

The Board will meet February 20 at the museum at noon. The next general meeting will be March 7, 2013 at the Plain Township Fire Station.

## NEW ALBANY-PLAIN TOWNSHIP HISTORICAL SOCIETY GENERAL MEETING MARCH 7, 2013

Several months ago the Board gave approval to Justin Varney to use the Museum for his senior project. The project was to be a video of meeting of Heads of State preceding the onset of World War I. The meeting was filmed in the back parlor. Before our March meeting, Justin and his group presented the video of his Senior Project entitled <u>THE DOGS OF</u> WAR. It was most impressive and appreciated.

Margaret Regrut, President, called the meeting to order. Liz Feichter read the Minutes of the February meeting. Helen Pestel made a motion to approve and Kathy Yager seconded. The motion passed.

Helen Pestel gave the financial report and David Cline made the motion to accept. Betty Maynard seconded and the motion passed.

We finally received a second bid, of sorts, for reconstruction of the pantry from Davyd Miller. There was no final cost, just \$80 per hour plus material. He stated drywall for the walls, not plaster, and laminate for the flooring instead of the hardwood.

During the discussion of this bid and the one from Ron Davis, Liz Feichter mentioned what Mr. Davis had done before and how well satisfied we have been. His estimate was between \$4620 and \$5000 and did include plastering walls. Helen Pestel made a motion to accept the bid of Ron Davis. Robert Dean seconded and the motion passed. One more item on our "to-do-list" accomplished.

The attic is almost complete except for the pipes.

No information on installation of the sign.

A resident near the Links e-mailed that he is appalled by the condition of the Dryer House. There has been no reply to our letter to our letter of February 19<sup>th</sup> to Joe Ciminello.

The COC Spring Fling is March  $21^{st}$  and the Museum will be open. We will have one table and will have our brochures; picture of the July 4 Community will be available. Naomi Fodor will be available in the front Ealy parlor to greet guests.

Founders Day is May 18<sup>th</sup>. We will need help in the gym and also at the Open House. In the gym, we will display the quilt, Schleppi art,

and other artifacts. We were told there will be people from Roscoe Village and also our neighbors in Harlem Township attending. Harlem Township Days are scheduled August 17 and 18.

Name tags approved by the Board are in progress. The cost is \$86.00.

A reporter from New Albany Life Magazine met with some of the Monday morning workers. We will be included in the June issue and have the opportunity to have a small article in monthly. It presently goes to 5,000 residences.

There was no report from the Constitution-ByLaws Committee. The first meeting is scheduled for March  $19^{th}$  at 1 PM at the home of Liz Feichter.

Monica Morgan asked that we send Dennis Keesee a thank you note for his meeting in February as well as one to Justin Varney. Liz Feichter will do so.

Nancy Ferguson made a motion to get some estimates to make the Dryer House presentable by removing plaster, cleaning out the house of debris and carpets.

Monica Morgan talked about the 200 Year celebration of Columbus and the exhibit at COSI. It will be there until the end of May.

THE WIDELY SCATTERED SMITHS

Over the years we have been getting requests from Plain Township descendents around the state and around the country for genealogical information and pamphlets. Well, by far the most of such requests come from Smiths, all descended from either Archibald himself or from Archibald's own forebears. We have heard from Smith descendents in Maine, New York State, New Jersey, Pennsylvania, Virginia, Georgia, Texas, Missouri, Iowa, Colorado, Utah, Idaho, Nevada, Arizona, California, and of course Ohio. Due to all these Smiths and their requests for pamphlets, we have had to order big batches of reprints in recent months of <u>The Autobiography of Pioneer</u> <u>Archibald Smith</u> and <u>Revolutionary War Veterans in Plain Township:</u> John Clouse and John Smith. DENNIS KEESEE'S talk at our Feb. 7 meeting added to our information about Lucius Smith, son of Archibald and indefatigable Diary-Dennis owns Lucius's 1855 and 1864 Diaries, which he writer. There is a tremendous amount of brought along to show us. information in these Diaries about life in Plain Township--for instance, photography in the 1850's (Lucius was a photographer's assistant for a time). Dennis is particularly interested in Civil War details. Lucius records in 1864 that all men aged 18-45 were to be drafted. He names men who went to war and mentions battles. Dennis added further information, making Lucius's material even more interesting.

THE UNDERGROUND RAILROAD IN OHIO was the subject of a talk at Otterbein University on Feb. 10. The seven members of our Society who attended found the talk very informative. We did not learn of any Underground stations in Plain Township, but the speaker did not rule out the possibility. We had the privilege of touring the Hanby House (a well-documented Underground station) after the talk. Our whole Society was invited to come for a special tour of it sometime.

The film of a one-act play, THE DOGS OF WAR, by high school senior Justin Varney, created a dramatic opening to our March 7 meeting. The play had been filmed in the back parlor of the Ealy House, with students taking the parts of 7 European leaders (including Czar Nicholas, King George V, Kaiser Wilhelm, etc.) supposedly meeting in July 1914 in a futile attempt to avoid World War I. It was a very ambitious project, which doubtless taught the students a lot of history in doing it.

On March 18 a TROOP OF BROWNIE SCOUTS provided the next bit of excitement. They loved their tour of the Ealy House, especially since each girl was provided with a "Scavenger Hunt" list and a pencil. They were especially excited about finding the 4 dolls, the pump organ (which caused confusion in some with the water pump outside), the stereoscope, and--the real high point--the "secret pass-through cupboard."

Three days later, ANOTHER TOUR, this one for adults who were also visiting the "SPRING FLING" EXPO across the street. We had a small but enthusiastic crowd in the Ealy House and even signed up two new members. Meanwhile, at the Expo, our Historical Society's booth attracted some interest, especially for our old maps displayed on easels, and for our 2012 panoramic group photograph (with a few more identifications being made).
